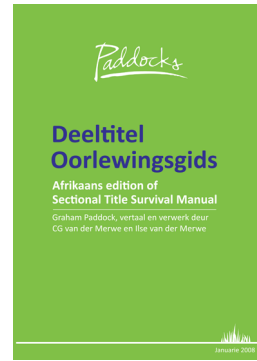
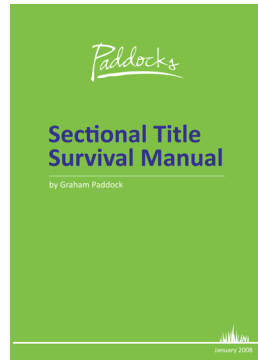




# Information pack
